FAMILY SHELTER PROGRAM - OUR EMERGENCY SHELTER PROGRAM IS A COMMUNITY-BASED PROGRAM WHERE FAMILIES EXPERIENCING HOMELESSNESS ARE ABLE TO IMMEDIATELY GET OFF THE STREETS AND STAY IN LOCAL CONGREGATIONS WHILE THEY SEEK EMPLOYMENT AND HOUSING. WHILE IN THE PROGRAM, OUR FAMILIES PAY NO RENT AND ARE PROVIDED THREE MEALS A DAY BY A TEAM OF VOLUNTEERS. DURING THE DAY, PARTICIPANTS RECEIVE INDIVIDUALIZED CASE MANAGEMENT FROM OUR STAFF AT OUR FAMILY DAY CENTER LOCATED IN CAMAS, WASHINGTON. FAMILIES IN OUR PROGRAM HAVE ACCESS TO CASE MANAGEMENT WHERE THEY ARE PROVIDED WITH RESOURCES FOR EMPLOYMENT, FINANCIAL LITERACY, AND HOUSING. FAMILY SHELTER ACCOMPLISHMENTS: 1) TOTAL SERVED:44; 2) PERCENTAGE OF FAMILIES GRADUATING TO SAFE AFFORDABLE HOUSING:85%; 3) NUMBER OF MEALS SERVED:11,220; 4) NUMBER OF BED NIGHTS PROVIDED:3,740.
